- 3. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to form and nature of the site, the means of access to the site, the accommodation they may required and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender.

- 5. Tenderer shall quote rates inclusive of all taxes and levies/duties considering the latest Govt. order/Circular/notifications on the AGST and other duties.

- 23. ### TERMS AND CONDITIONS GOVERNING THE TENDER AND EXECUTION OF CONTRACT THEREOF

#### 1. **DEFINITIONS**:

- a) Unless otherwise required by the subject or context the terms herein below shall have the following meanings.
  - The Contract means the documents forming the tender and acceptance thereof and the formal agreement executed between the competent authority on behalf of AFDC Ltd and the contractor, together with the documents referred to therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by the Managing Director, Assam Fisheries Development Corporation Ltd(AFDC Ltd) or the Exececutive/Asstt. Executive Engineer ,AFDC Ltd on behalf of M.D, AFDC Ltd and all these documents taken together shall be deemed to form one contract and shall be complementary to one another.
- b) Employer means Managing Director, AFDC Ltd, VIP Road, Chachal, Guwahati.
- c) The Contractor shall mean the individual, firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative such individual or the persons composing such firm or company or the successors of such firm or company and the permitted assigns of such individual, firm or company.
- d) The expression works or work shall, unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent and whether original, altered, substituted or additional.
- e) The site means the land/ water area of Rupaibali beel, Cachar on ,into or through which work is to be executed under the contract.
- f) TENDER VALUE means the value of the entire works as stipulated in the letter of award/acceptance.
- g) Whether the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
- h) As stated in Section- III, Clause-1.1, the General Conditions of Contract for APWD works shall be the guiding principles for this Tender. The Clauses of contract mentioned therein shall also be applicable herein and only those Clauses that need addition, emphasis and modification in context of this tender enumerated below. Contractors are once again advised to familiarize themselves with the General Conditions of Contract for APWD Works.

#### 2. SIGNING OF CONTACT AGREEMENT:

- i) On the Tender being accepted by the Employer, a formal contract may be signed and executed by and between the employer and the successful tenderer within a time to be fixed by the Employer which shall anyhow be within 15 days from the stipulated date of start of the work.
  - ii) The contractor shall be furnished free of cost one certified copy of contract documents except standard specifications, Schedule of Rates and such other printed and published documents, together with all drawings as may be forming a part of tender papers. None of these documents shall be used for any purpose other than that of this contract.

#### 3. SCOPE OF CONTRACT:

- j) The work to carried out under the Contract shall, except as otherwise provided in these conditions, include all labour, materials, tools, plants equipment and transport which may be required in preparation of and for and in full and entire execution and completion of the works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion of the work as a aforesaid in accordance with food practice and recognized principles.
- ii) The contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works and of the rates and prices quoted in price bid which rates and prices shall, except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion and maintenance of the works.

#### 4. DISCREPANCIES AND ADJUSTMENT OF ERRORS:

- i) The several documents forming the Contract are to be taken as mutually explanatory of one another, detailed drawings in respect of Cage & Pen culture and figured dimensions in preference to scale and special conditions in preference to General conditions.
- ii) If there are varying or conflicting provision made in any one document forming part of the contract, the Managing Director AFDC Ltd shall be the deciding authority with regard to the intention/ interpretation of the document and his decision shall be the final and binding on the contractor.
- iii) Any error in description, quantity or rate in Schedule of Quantities or any omission there from shall not vitiate the contract or release the Contractor from the execution of the whole or any part of the works comprised therein according to drawings and specifications or from any of his obligations under the contracts.

#### 5. TERMS OF PAYMENT:

Subject to any deduction, which the Employer may be entitled to make under the Contract, all payments to contractor for the work would be made by Cheque/ Demand Draft/RTGs in favour of the contractor on Satisfactory completion report and signing of the measurement book & bill by the Site engineer including Check measurement by Executive/Asstt. Executive engineer without which payment will not be released.

#### 6. **SECURITY DEPOSIT:**

10% security Deposit will be retained by the AFDC fro the bill value, which shall be released after 160 days fro the date of completion of the work and final acceptance of the work by AFDC Ltd. During this defect liability period, any defect/defects in the work done shall be rectified by the Contractor at his /her own cost and expenses, failing which recovery shall be done from the security deposit in part or full as the case may be.

#### 7. SUB CONTRACTING OF THE WORK:

The contractor is not permitted to assign or transfer his/their obligation or benefit under the contract either in full or in part to other individuals/firms/agencies. However, under the extreme circumstances where sub-contracting of part of the work is unavoidable, prior written permission of the Employer shall be taken by the contractor.
